- Account management fee **HUF 0**
- Above the age of 14, your Mastercard® Online Junior card is issued with the PayPass function, therefore you can make purchases with a touch. By default, for purchases under HUF 15,000**, it is not required to enter your PIN code, making purchases faster and easier.
- Issuance and annual fee of the Junior debit card: **HUF 0**
- With your debit card, you're eligible to use the following services free of charge
 - Mobil phone top up: **HUF 0**
 - Online purchases: **HUF 0**
- Pursuant to Section 36/A of Act LXXXV of 2009, cash withdrawal is free of charge twice a month, up to the amount of HUF 150,000, subject to making the relevant statement.
